- \$8.4 million in Reentry Projects grants have been awarded to 41 non-profits and local and state governments to create models that offer apprenticeship opportunities as well as increased employment outcomes for eligible participants.

- National Institute of Corrections \rightarrow Transition and Offender Workplace Development
- The Community Services Division coordinates the efforts of federal, state, local, and non-profit
 agencies to improve employment programs for offenders and ex-offenders. The division assists
 corrections professionals who provide direct services to offenders and ex-offenders. The
 Community Services Division:
 - Collects and disseminates information on offender employment programs.
 - Provides training for staff who provide employment services to offenders and exoffenders.
 - Provides assistance to state and local agencies for improving job training, placement, and retention services for offenders.
 - Develops partnerships with federal, state, and local agencies to provide offender workforce development training in their home jurisdictions.

US Department of Education - Second Chance Pell Program

- Pilot program, launched by the Obama administration which provides Pell Grant eligibility at 67 participating colleges and universities. The colleges partner with more than 100 federal and state penal institutions to enroll roughly 12,000 incarcerated students. These institutions may provide Pell grants to qualified students who may be released within five years of enrolling.
- On February 13, 2019, the Trump administration extended the program for a fourth year.
