The Florida Corporate Income Tax Credit is contingent, in part, on the eligible business having received the federal research and development tax credit. Taxpayers will be able to apply to the Florida Department of Revenue (DOR) for an allocation of the Florida Research and Development Credit beginning on March 20, 2020. Applicants will be required to include a letter from DEO certifying the applicant is an eligible target industry business when submitting an Application for Allocation of Credit with DOR.
