Dear NTMA Member:

This NTMA Business Conditions Report; dated June 30, 2020, obviously comes out during one of the most challenging times for our businesses and our country. It is our hope that this benchmarking information will be helpful and informative to you.

This report covers the first half of 2020, a projection for the second half of 2020, and is a geographical "snapshot" of business trends and conditions in the special tooling and machining industry.

This Report, is based on information from 111 NTMA member companies, up from 57 companies in December 2019. Results indicate that overall business conditions during the 6-month period ending June 30, 2020 were "Very Good to Excellent" for 18% of respondents, down from the previous report of 44%. Looking ahead, 44% are projecting that the next six months will bring a "Moderate-to-Substantial Increase" in business conditions, this being down from 63%.

Average work week per employee increased to 49 hours up from 43 hours, while future work on the books remained at 16 weeks.

Of those companies participating, the industry segment breakdown was as follows;

- 49% of participants reported Aerospace & Ordinance as 43% of their business
- 43% of participants reported Medical as 23% of their business
- 32% of participants reported Automotive as 24% of their business
- 55% of participants reported Other as 29% of their business

Of all the companies participating, 81% they were actively soliciting new customers.




Thinking about the 3 industry segments that comprise the majority of your business, what percentage is devoted to each?


49% of Participants reported that Aerospace & Ordnance is an average 43% of their business

32% of Participants reported that Automotive is an average 24% of their business


In closing 55% of Participants reported that a combination of Other Industries (not listed) were on average 29% of their business








