Basic projects that create at least ten new jobs in metropolitan areas, or at least five new jobs in non-metropolitan areas, within two years may be eligible for up to seven years of payroll withholding tax savings.</p> <p>Larger, high-impact projects that create at least 100 new jobs within two years may be eligible for up to ten years of payroll withholding tax savings.</p>	Kansas Department of Commerce	Tax Credit	Rolling	PEAK applications are accepted year-round and must be submitted prior to locating, relocating or hiring new jobs in Kansas. Registered Apprenticeship sponsors are exempt from paying overtime to apprentices for the related instruction portion of their training if it is outside normal business hours.
