The program’s goal is to increase apprenticeship availability to Pennsylvania employers to assist them with their talent recruitment and development.</p> <p>Sponsors of registered apprenticeship programs are eligible to apply. Sponsors include: single employer, employer consortiums, workforce development boards, economic development organizations, labor organizations, local career technical education institutions, Pennsylvania community colleges and community organizations or associations. Group models are highly encouraged.</p> <p>Eligible uses of funds are expenses related to instruction that complements on the job training, delivering the technical as well as academic competencies that apply to the job.</p>	<p>Department of Community and Economic Development</p>	<p>Each employer is eligible for \$3,000 per apprentice, with a max of five apprentices per year, for three years.</p>	<p>Applications will be accepted and evaluated on an ongoing basis with awards to be made to eligible applications for as long as funds are available.</p>

May be used for Machinery/equipment; Job training; Infrastructure; Land and building improvements; Environmental assessment/remediation; Acquisition of land, buildings, right-of-ways; Working capital; Site preparation.</p>	<p>Department of Community and Economic Development</p>	<p>The maximum assistance amount shall not exceed \$5,000 for each job projected to be created or retained. The Department has discretion to modify this amount for special circumstances. The interest rate for loans shall be set quarterly based on the 10-year Treasury rate. Loan terms will not exceed 15 years for real estate and infrastructure or 10 years for machinery and equipment. There is a 1% commitment fee on all approved loans.</p>

Participation is limited to two years in a row and three out of the past five years.  Training must commence by February 1st or by the end of the fiscal year, whichever comes first. If not, the funds will be forfeited.  Point-of-sale retail businesses, gaming establishments, training vendors, employment agencies, government agencies, government-owned facilities, education and nonprofit entities are ineligible.  Employers must be manufacturing or technology businesses including Biotech and Environmental-Tech companies.  Employees must be frontline employees or first-level supervisors.  On-the-job and orientation training do not qualify for the program.
