Employers or organizations of employers may apply for grants to reimburse expenses related to instruction toward attaining an industry-recognized degree, certificate or credential for their employees.</p> <p>A grantee can receive up to \$150,000 a year of which a dual trainee can benefit up to \$6,000 per year. Grantees receive funds through a reimbursement process. Grantees pay related instruction costs and OHE reimburses grantees for related instruction costs. In some cases, a cost match is required of grantees. These local partnerships provide students with related classroom instruction, safety training, industry-recognized credentials and paid work experience in high-growth and high-demand occupations in the industries of advanced manufacturing, agriculture, automotive, health care and information technology. Successful applicants will demonstrate the ability to achieve these objectives through various means including outreach, education, training and supportive services for students.</p> <p>Grant funds can be used for marketing, recruitment, training, transportation, student certifications and personnel to manage a program. Eligible applicants include businesses located outside of the seven county metropolitan area or located in the cities of Hanover, Rockford, Northfield and New Prague that are adding at least three new jobs. The new jobs must pay wages at least equal to the median weekly wage for the county in which the jobs are located. The new jobs must also provide at least 32 hours of work per week for a minimum of nine months per year. Businesses are required to match the grant on a 5:1 basis. The program provides grants of up to \$200,000 to Minnesota public, private, or nonprofit entities that provide employment services to low-income individuals. Minnesota participating businesses must partner with an accredited Minnesota educational institution. Grants of up to \$400,000 are awarded to the educational institution to develop and deliver custom training specific to business needs. All projects must have at least one educational institution and one business working together. A cash or in-kind contribution from the participating business must match the grant funds on at least a one-to-one basis. Eligible educational institutions must be accredited through institutional or specialized accrediting agencies that are recognized by the U.S. Department of Education and/or the Council for Higher Education Accreditation. Projects average one to three years in duration. <p>Pathways Program</p>	<p>https://mn.gov/department/business/financing-business/training-grant/pathways/</p>	<p>The Pathways program focuses on providing training, new jobs and career paths for people who have incomes at or below 200 percent of the federal poverty guidelines or those who are making a transition from public assistance to work. Projects must include at least one participating business and an accredited Minnesota educational institution or training provider. Grants of up to \$400,000 per project may be awarded to develop and deliver training specific to business needs. Cash or in-kind contributions from the participating business(es) must match program funds on at least a one-half to one ratio. Eligible applicants include accredited Minnesota educational institutions and workforce development intermediaries partnering with businesses within the state. Workforce development intermediaries are defined as public, private or nonprofit entities that provide employment services to low-income individuals. <p>Border-Cities Enterprise Zone Program</p>	<p>https://mn.gov/department/business/financing-business/tax-credits/border-cities/</p>	<p>The Border-Cities Enterprise Zone Program provides business tax credits (property tax credits, debt financing credit on new construction, sales tax credit on construction equipment and materials, and new or existing employee credits) to qualifying businesses that are the source of investment, development, and job creation or retention in the Border-Cities Enterprise Zone cities of Breckenridge, Dilworth, East Grand Forks, Moorhead, Ortonville, and the Development Zone of Taylors Falls.
